



## **Privacy Policy**

New Path Therapy is committed to protecting and respecting your privacy. This Privacy Policy explains how your information is collected, used, disclosed, and safeguarded when you visit the website [newpaththerapy.co.uk](http://newpaththerapy.co.uk) ("Site"). Please read this policy carefully to understand the views and practices regarding your data and how it will be treated.

### **1. Information collected**

New Path Therapy may collect and process the following data about you:

#### **1.1 Personal Identification Information:**

- Name
- Email address
- Phone number
- Address

#### **1.2 Technical Data:**

- IP address
- Browser type and version
- Time zone setting
- Browser plug-in types and versions
- Operating system and platform
- Other technology on the devices you use to access this Site

#### **1.3 Usage Data:**

- Information about how you use the website, products, and services.

## **2. How Your Information is used**

New Path Therapy uses the information collected in the following ways:

### **2.1 To Improve the Services:**

- To understand how the Site is used to improve user experience
- To administer and protect the business and this Site

### **2.2 To Communicate with you:**

- To send administrative information to you
- To respond to your enquiries

## **3. Sharing Your Information**

Your information may be shared with:

### **3.1 Service Providers:**

- Third-party vendors, consultants, and other service providers who perform services on behalf of New Path Therapy

### **3.2 Legal Obligations:**

- If required to do so by law or in response to valid requests by public authorities

## **4. Cookies**

New Path Therapy uses cookies and similar tracking technologies to track the activity on the Site and hold certain information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of the Site.

## **5. Data Security**

New Path Therapy has implemented appropriate technical and organisational measures to ensure a level of security appropriate to the risk of personal data processing. However, please remember that no method of transmission over the internet, or method of electronic storage, is 100% secure.

## 6. Your Data Protection Rights

You have the following rights regarding your personal data:

- **Access:** The right to request copies of your personal data.
- **Rectification:** The right to request that New Path Therapy correct any information you believe is inaccurate or complete information you believe is incomplete.
- **Erasure:** The right to request that we erase your personal data, under certain conditions.
- **Restriction of Processing:** The right to request that New Path Therapy restrict the processing of your personal data, under certain conditions.
- **Objection to Processing:** The right to object to the processing of your personal data, under certain conditions.
- **Data Portability:** The right to request that New Path Therapy transfer the data collected to another organisation, or directly to you, under certain conditions.
